  AGM, for parents interesting in learning more about home & school. We were able to fill many volunteer spots for 2019
  events as well as vote in a full team of executive members.

- A newsletter for regular distribution throughout the year is in the works by the publicity and membership team in order to inform our school community of upcoming events and how their contributions have helped the schools.
- Pizza/subway lunches first 2 lunches were distributed by volunteer parents with very few issues. After receiving requests for changes to lunch orders and many missed deadlines, H&S reopened the online site for additional orders and changes until September 30th.

#### 2. Ongoing events:

- Pizza and Subway lunches (2 lunches per month)
- Tea Trolleys for staff at both Campuses— once a month H&S parents donate baked goods and a "trolley" goes class to class so teachers can enjoy a quick tea/coffee and dessert break.

#### 3. Upcoming events:

- H&S will be covering the cost of the Bagpiper to play at both the JR and SR Remembrance Day events.
- Family Game Night: as a replacement to the traditional Welcome event, the Family game night to be held on October 16<sup>th</sup> from 6pm to 8pm at the Senior school gym. The event will be hosted by All Aboard Games. The event is not to be considered a fundraising initiative however we hope to break even. For this reason, admission will be 2\$ per participant over the age of 5. Pizza will be available for pre-order. Popcorn, drinks and pizza by the slice will be available for sale at a modest price at the event.
- Children's Bazaar (December 13, 2019 @ JR school) no fundraising to be done, extra costs to be covered by H&S.
- Annual Holiday Baskets (November/December 2019) Not a fundraising initiative. Great opportunity for the school to
  give back to the community and collect non-perishables from the school families to create baskets for the less fortunate.
   Baskets are created for families in need with non-perishable item donated by Sherbrooke Academy families (school
  collection). H&S will purchase perishable items to add to the food baskets thanks to funds raised from the Holiday Fair

  initiatives by H&S, its objective is to raise funds by raffling off gift baskets and gift certificates filled with items collected

  guardians. Event committee members solicit community businesses for donations.
