Resolution number 2020-11-#15

Calendar 2020-2021 (Youth Sector) - Amendment

- WHEREAS in accordance with section 238 of the *Education Act*, every School Board shall establish the school calendar of its schools, taking into account the provisions of the *Basic School Regulation*; and
- WHEREAS due to the pandemic, the *Basic School Regulation* was amended on October 28, 2020, to determine that the school calendar shall consist of at least 177 days of educational services in order to add 3 additional pedagogical or training days to the 2020-2021 school calendar; and
- WHEREAS regarding the 3 additional allocated PD days, the proposed amendments are as follows:
 - a) School level: 1 additional PD day to be determined at the local level;
 - b) Board level: a distance learning PD on January 25, 2021, and a distance learning PD on February 8, 2021;
 - c) Daycare level: a PD for Daycare and Lunch employees on February 15, 2021 (no daycare services offered on that day).
- WHEREAS as per sections 193 (7) and 244 of the *Education Act*, the Parents' Committee and the teachers are be consulted on the school calendar; and
- WHEREAS Governing Boards are consulted on the schedule of the Daycare Services; and
- WHEREAS the Council of Commissioners also wishes to consult the Central Students Committee:
- WHEREFORE IT WAS MOVED BY Commissioner J. Doan AND UNANIMOUSLY RESOLVED:
- THAT the Parents' Committee, teachers and the Central Students Committee be consulted on the proposed amendment to the LBPSB 2020-2021 school calendar; and
- THAT the schools' Governing Boards be consulted on the proposed amendment to the Daycare schedule; and

THAT responses be provided to the Secretary General by Thursday, December 3, 2020, for adoption of the amended calendar at the Council meeting of December 7, 2020.

- WHEREAS by virtue of resolution 2020-06-#05, the Council of Commissioners adopted the schedule of its meetings and the Executive Committee meetings for the 2020-2021 school year up to September 21, 2020; and
- WHEREAS the newly formed Council of Commissioners must adopt the schedule of meetings for the rest of the 2020-2021 school year in accordance with sections 162 and 182 of the *Education Act*; and
- WHEREAS Order in Council 1039-2020 makes mandatory for the public wishing to attend Council meetings to do so by virtual means until further notice; and
- WHEREAS amendments to By-law 1 (2020) and By-law 1E (2020) are proposed; and
- WHEREAS in accordance with section 392 of the *Education Act*, said drafts must be sent to Governing Boards as well as to the Parents' Committee, and a public notice must be given; and
- WHEREAS the School Board also wishes to receive additional input from its consultative partners, including the Central Students' Committee:
- WHEREFORE IT WAS MOVED BY Commissioner M. Shaheed AND UNANIMOUSLY RESOLVED:
- THAT the drafts of amended By-law 1 (2020) To fix the Day, Time and Place of the Regular Meetings of the Council of Commissioners 2020-2021 and By-law 1E (2020) To fix the Day, Time, and Place of the Regular Meetings of the Executive Committee 2020-2021 be distributed to the consultative partners during the week of November 9, 2020, with responses to be returned to the Secretary General by Thursday December 3, 2020, and that a public notice be given; and
- THAT said by-law be submitted for adoption at the Regular Meeting of the Council of Commissioners to be held on December 7, 2020.

Admin Report November 19, 2020

Good evening,

Please see the following points of information or highlights that have arisen since our last GB meeting:

- 1. Things have been relatively quiet since Halloween. Absences are low. Teachers have been encouraged to really focus on instruction and evaluation.
- With the uncertainty surrounding the length of the December break, teachers can not count on the two weeks after the break to complete evaluation and marking. The majority of student evaluation and grading will be done by Dec. 18th.
- 3. Parent/Teacher Interviews take place next week. Interview dates are Nov. 25th and 26th. Parents should be able to book appointments as of Wednesday at 4:00pm. The booking process closes on Monday at 9:00am.
- 4. The Winter Entry Plan has started and is going well. It has been several weeks since having indoor and outdoor shoes, and access to cubbies and hooks. The classes are a lot cleaner and less crowded.
- 5. The playground committee has met and we are looking into how we can upgrade the schoolyard. The process is ongoing. The companies should be coming by the end of this week to survey the property and give us quotes.
- 6. Some landscaping work was done on the schoolyard last week. The brush was cleared from the staff parking lot and the bike rack was moved to the front of the building to make it safer. Feedback so far has been very positive.
- 7. The LBPSB is planning a virtual Open House for all schools on January 19th. Video crews are going to every LBPSB school to create a 2 min. Film crews will be at St. Edmund on December 8th. Permission forms are required in order for a student to participate in the video.

8. The recent announcements to add three PED days to the calendar as well as the announcement for online instruction on the 17th and 18th of December will most certainly have an impact on the current school calendar year. To start, we would like approval to officially change the end of term 1 to December 18th. Report Cards will be issued on January 22, 2021. There will be additional changes once we have processed the government's recent announcements.

Each year, thousands of injured and orphaned birds receive care at their centre in Hudson, Quebec. Café Le Nichoir is the result of collaboration between Le Nichoir Wild Bird Conservation Centre and Totem Roasters. Café Le Nichoir encourages people to drink, Fair Trade, organic, Bird Friendly® certified coffee. They have offered to donate 10% from the sales of their coffee to our school whenever the person purchasing the coffee online uses the St. Edmund coupon tag. We will promote this fundraiser among St. Edmund families over the next couple of months and direct people to the Le Nichoir website to order their coffee. They will have the option of picking it up in person or having it shipped. We will do a second promotion of this fundraiser in the spring around Earth Day and we will likely arrange to have the coffee delivered to the school to send home with the kids.
